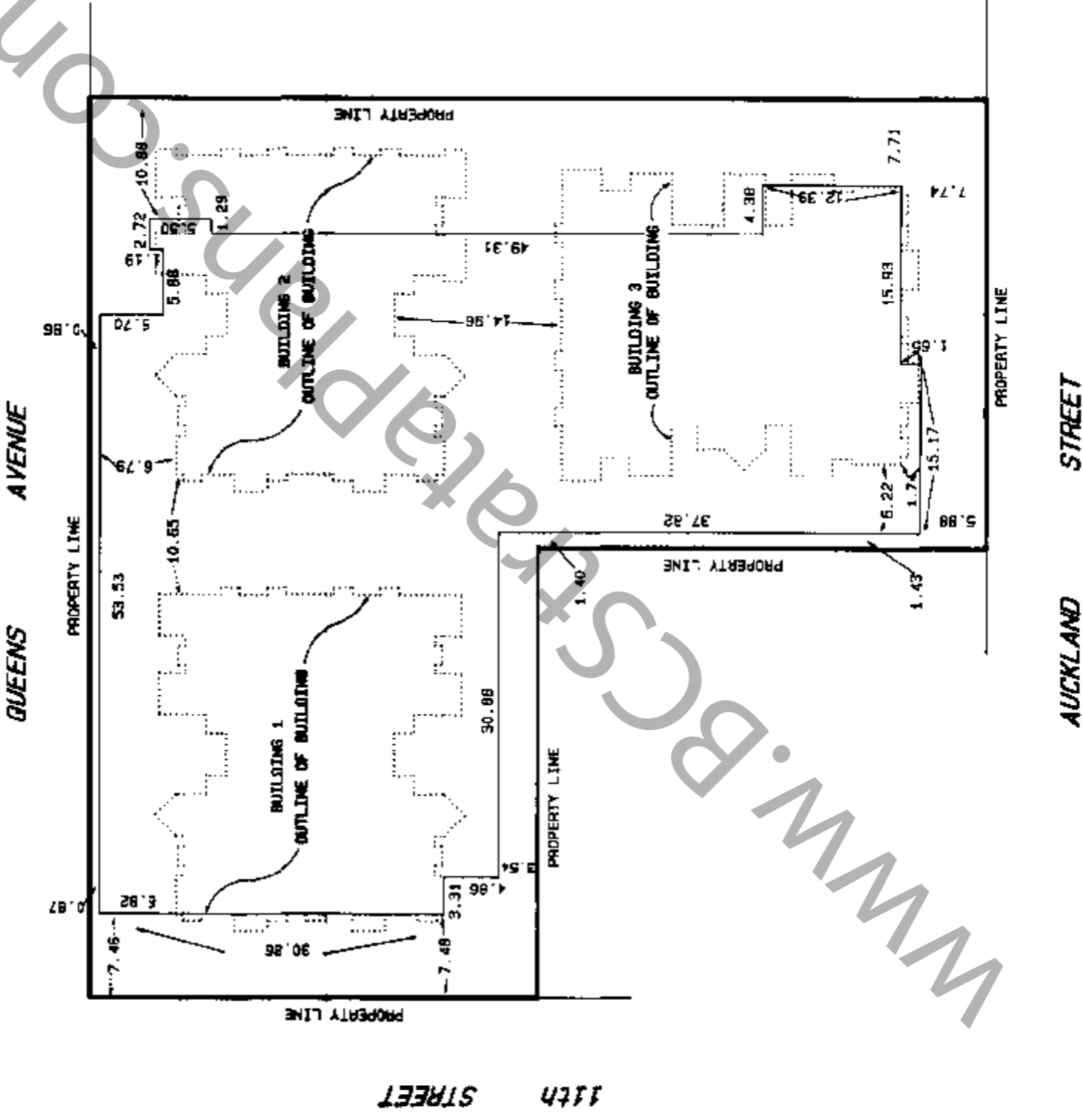

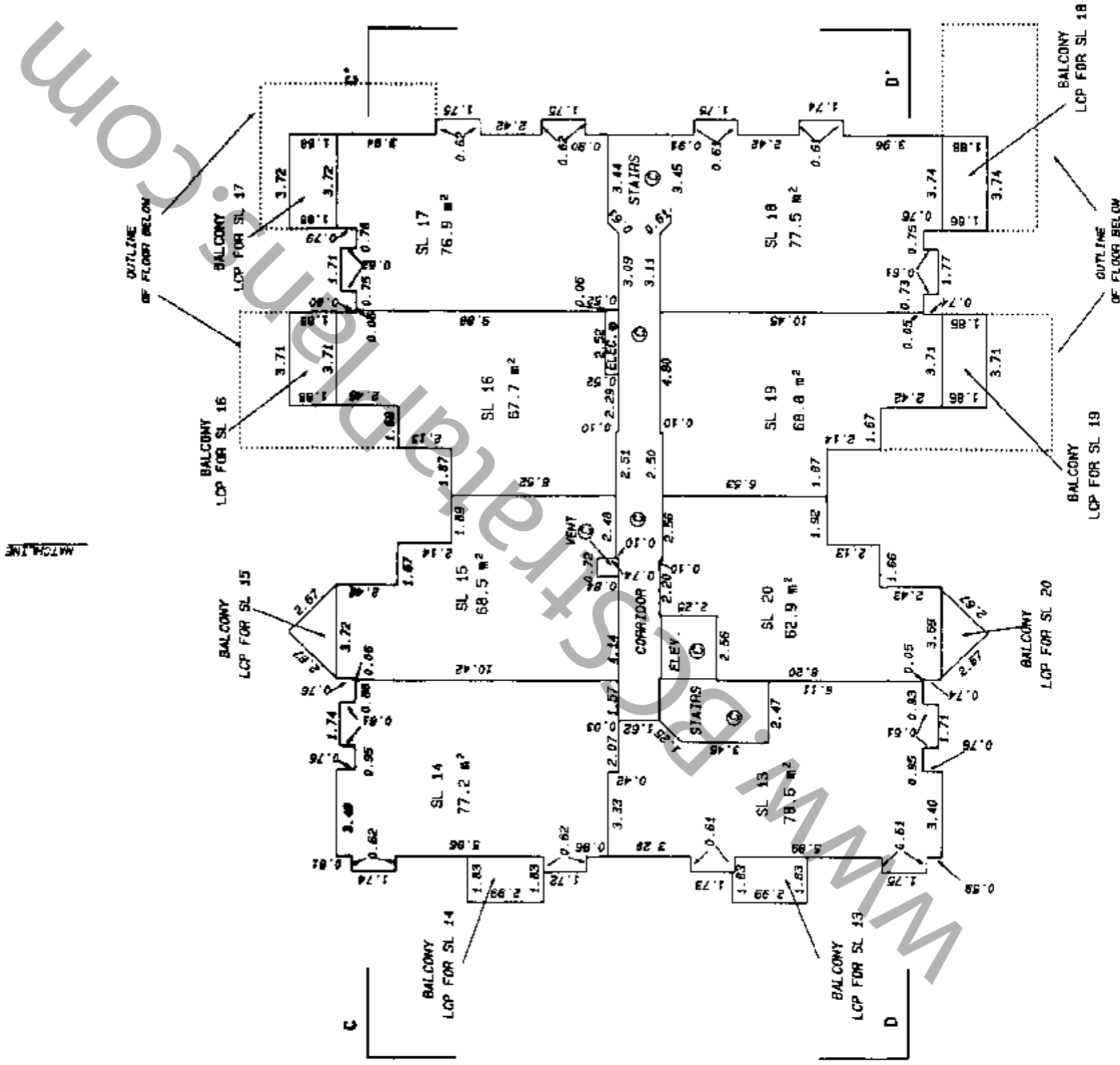
LEVEL 4 FLOOR PLAN

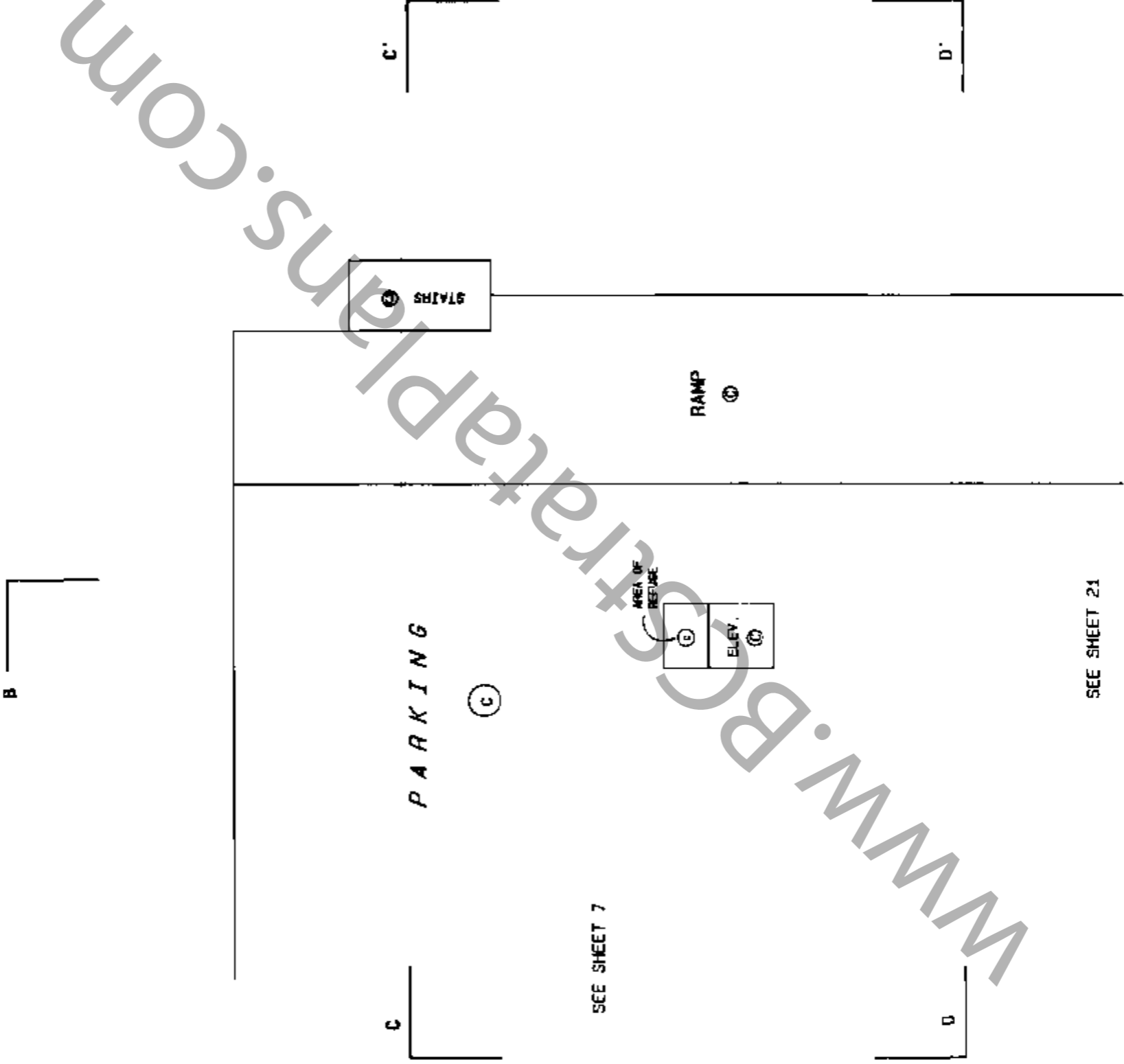
LEVEL 2 FLOOR PLAN

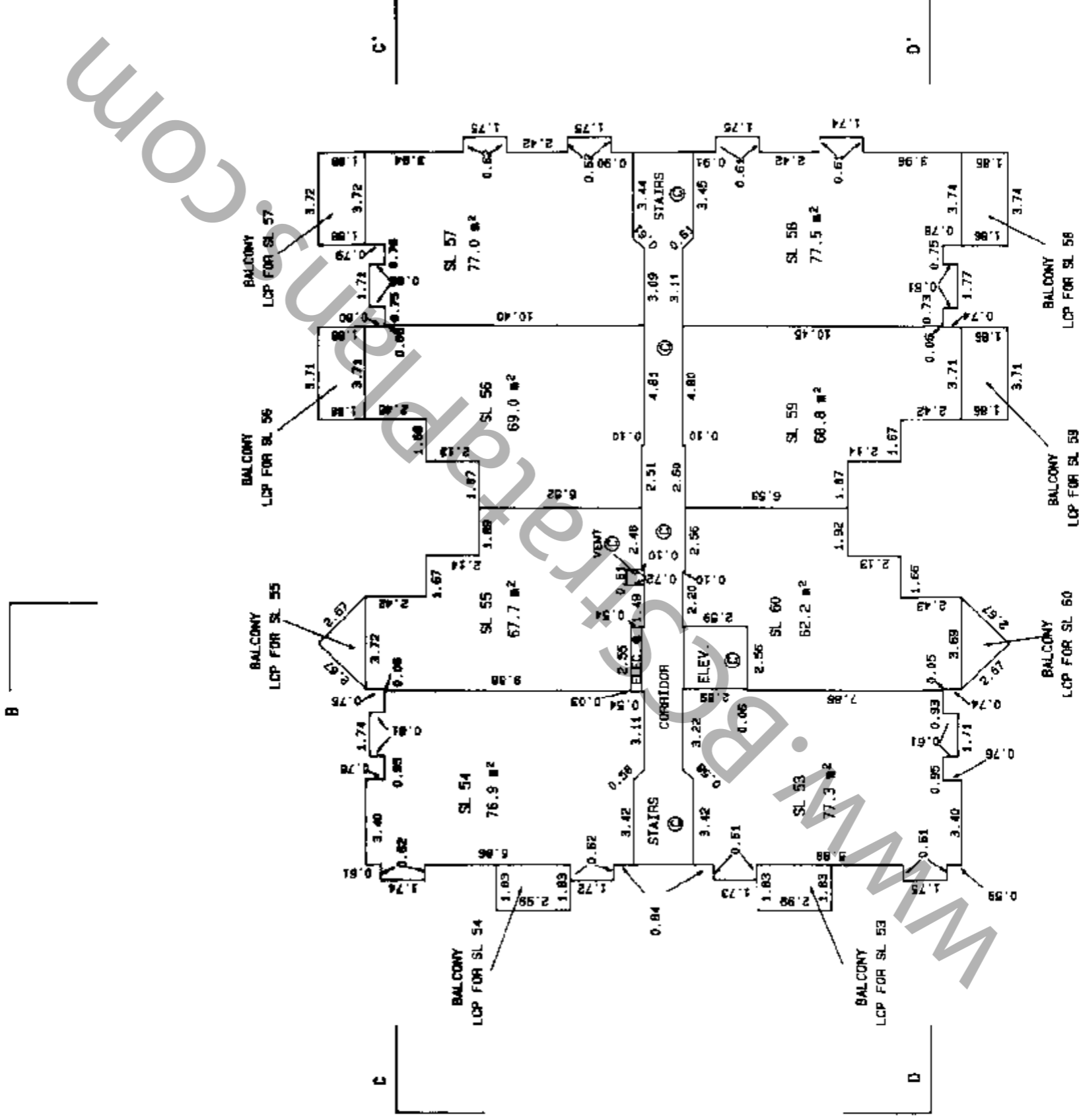

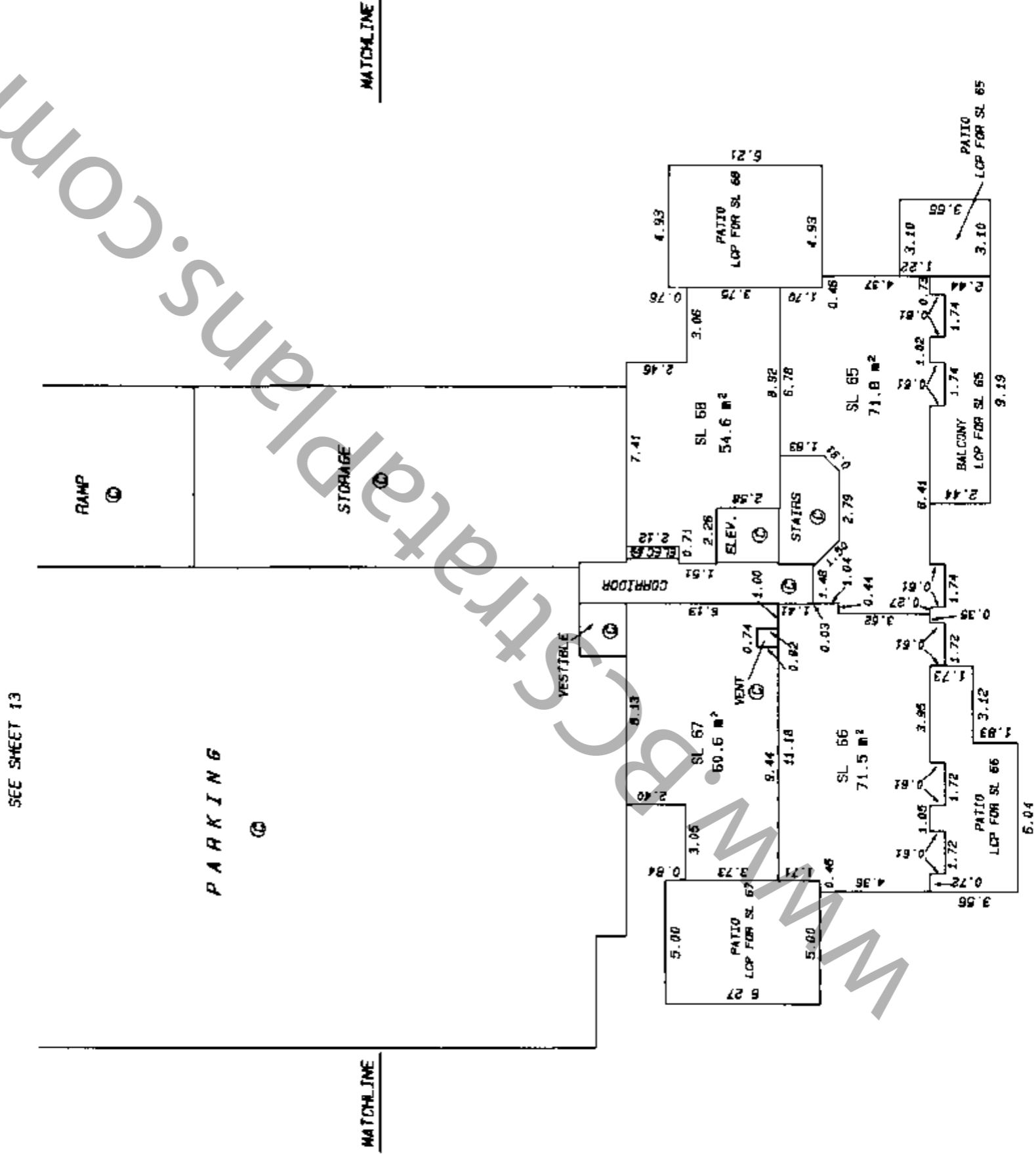
LEVEL 2 FLOOR PLAN

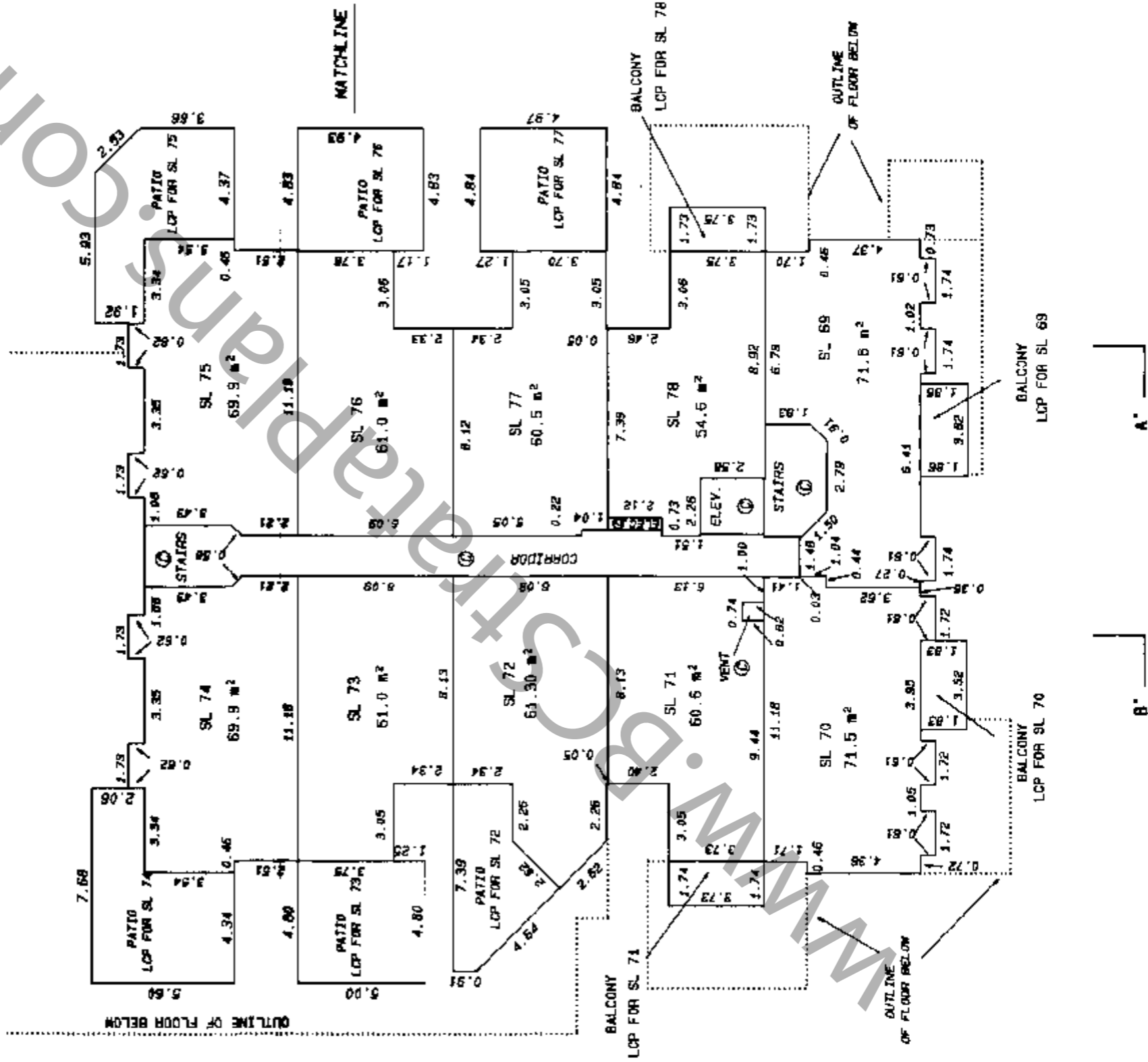

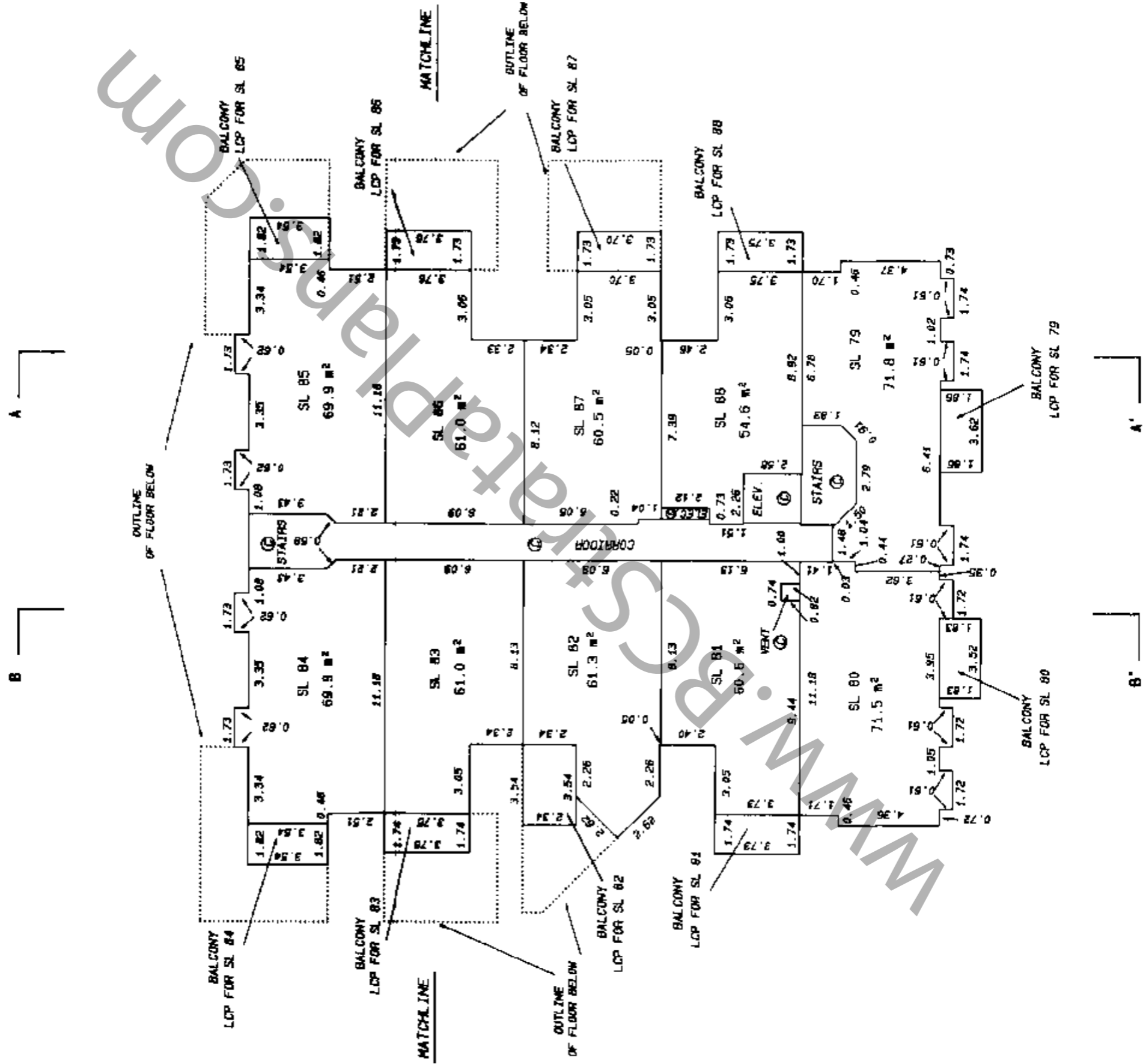
LEVEL 4 FLOOR PLAN
